

## **First Unitarian Church of Oakland Board of Trustees Minutes of August 23, 2011 Board Meeting**

The meeting was called to order at 7:30pm, in the Starr King Room at church.

### **Opening Reading and Chalice Lighting**

### **Consent Agenda**

- Approved the minutes of August 20, 2011 Board Retreat after it was first pulled for clarification. It was then moved and approved. Final edition to be available on the web site.
- Acknowledged the receipt of the Executive Report.

### **Quarterly Financial Report**

- Presented by Julie Baeder, Lay Person for Financial Health of the Coordinating Team.
- Questions and discussions followed so that the Board would better understand the significance of some of the numbers as well as the accounting system that is used.

### **Connecting with the Minister**

- Rev Kathy reviewed this church year's learning/worship theme: "Destino: Destination Vision 2012".
- The Board then took one of the reflection questions related to Family of Origin and used it as a conversational exercise.
- Rev Kathy presented the board with additional resources about multiculturalism, multicultural competencies, institutional change and the Continuum on Becoming and Anti-Racist, Multicultural Institution.
- The Board was encouraged to read "The Wolf Shall Dwell with the Lamb: A Spirituality for Leadership in a Multicultural Community", by Eric H.F. Law, Chalice Press. We were reminded that the author will be presenting the upcoming training during the Lead Weekend of Nov 4-5, 2011.

### **Guidelines for Minutes-taking for Board Secretary**

- We received a memo we requested from Louise Wolfgramm of Unity Consultants with regard to guidelines for Board Minutes using Policy Governance.
- An in-depth discussion followed with a wide range of perspectives presented.
- Rinda will draft a document for Board review detailing five characteristics that this Board will provide as Guidance to the Board Secretary.

### **2011-2012 Board Annual Priority #1: A full cycle of monitoring of Church Ends: including using a Congregational Survey**

- This priority was addressed by means of reporting in of Linkage and Congregation Reports.
  1. **Joy Full Noise** – a new music group is forming at the church
  2. **Throw Down For Oakland** – 40 folks participated in the cleanup at Old Man's Park
  3. **Clothing Exchange** was very successful and the group is considering how to include our neighbors in this exchange.

### **Transylvania Trip and Project Harvest Hope**

- Rev Kathy will inform us as to the link to a slide show of the Pilgrimage
- The age range of the people on the pilgrimage (18 church members and 2 guests) was from 9 to 81 years, with a strong youth contingent..
- There is interest in a follow up to this pilgrimage with Ok'land and joining with the Athens congregation to bring perhaps 5 people from the Ok'land community, perhaps in February 2013.
- Project Harvest Hope is changing how it operates and more information will be forthcoming.
- Harvest Hope was born out of this church's Transylvania Economic Development Task Force many years ago and now survives independently. Other than annual donations we do not have any formal connection.
