

First Unitarian Church of Oakland Board of Trustees
Minutes of October 25, 2011 Board Meeting

Opening Reading and Chalice Lighting

- Reading was presented by Margaret.

Consent Agenda

- Approved the minutes of September 27, 2011 Board meeting.
- Acknowledged the receipt of Senior Minister's Executive report, October 25, 2011.

Connecting with Church Coordinating Team: Program

- Linda Hodges and Kristen Montan outlined their responsibilities and the processes being used to connect with the congregation leadership.
- The Coordinating Team is responsible for the day to day administration and management of church operations and the health and success of our Every Member Ministry.
- The Program Duo is charged with the overall programming health in the church.
- The primary work so far is the revamping of the coffee hour into the new hospitality.
- The focus is on an inviting room of rainbow colors, personal connections and fair trade coffee served in coffee shop atmosphere.
- The hospitality hour is being hosted, on a rotational basis.
- People are finding it easier to connect with each other and they are staying longer.
- We are using good quality fair trade coffee.
- There is attention given to equal accessibility for all.
- This is part of our every member ministry and our spiritual co-op.

- We want to pay attention to this priority at each Board meeting.
- We need more resources, such as videos and articles that might stretched our perspectives.
- We want to purposefully build-in a couple of caucuses at Board meetings.
- We want to work on case studies.
- We will pay attention to what comes up at the LEAD weekend.
- We will pay attention to the way we are doing stewardship from the lens of anti-oppression.

Connecting with the Church Coordinating Team: Fiscal Health

- A detailed review of the 3 year budget projections was presented by Julie Baeder on behalf of the Finance Committee (Julie Baeder, Rev Kathy Huff, Linda Hodges).
- The preliminary 2012 Budget Assumptions as of 10/19/11 was presented.

- Rev. Kathy suggested that the policy regarding the establishment and membership appointments of the Stewardship Committee be clarified.

- Registration details for the upcoming LEAD weekend retreat were reviewed. As of today, there are 45 confirmed, 50-55 probably, 40 from Oakland, 10-15 from San Jose.

- Bob is hosting the guest speaker, bringing him from the airport, etc.
- Rachael Jeffries is the new Team Leader for the Leadership Development Team.
- Membership on the Team is Elinor Mattern, Linda Propert and Bob Crowe.

2011-2012 Board Annual Priority #2 (Stewardship)

- An update on our Stewardship work was presented.
- The first event of the Stewardship campaign, the Fall Fiesta, was a success.
